

The above transfer is subject to the following conditions:

- That the official is not entitled to any TA/TP/JT.
- That the official's seniority on transfer will be fixed under Rule-8 of BSNL Employees transfer policy as amended from time to time.
- That the official will have no claim for seniority in the new unit on account of the service rendered in parent unit.
- That he will not seek re-transfer to his parent unit before completion of 5 years of service in the new SSA/Circle.
- That his claim for the benefit of promotion, on having qualified in the departmental examination while working in the parent unit, shall be permitted subject to the condition that a request to that effect is made by within a period of six months of declaration of the result of the examination or finding a place in the select panel in cases where wait-listing of qualified candidates applicable.
- He has to forgo all his claims in the old unit, even if a permanent vacancy was available because of retrospective permanency of post or for any other reason entitled for confirmation against such post in his old unit/SSA.
- He will not claim for a posting in any particular station of the new SSA/Circle.
- He should accept all the terms and conditions laid down in the BSNL's employees transfer policy notified vide lr.no. 6-1/2007-Restg. Dated 7-5-2008.

Declaration to this effect may be obtained from the above official and kept in the service book before relief is effected. Before relieving the official, it should be ensured that there is no disciplinary/ vigilance case pending or contemplated against the official.
