


Subject: - Deferment of indefinite strike from 03.12.2018 - req.



The All Unions and Associations of BSNL (AUAB), vide letter No: UA/2018/44 dated 15.11.2018, issued notice for indefinite strike from 03.12.2018. Following this, talks were held between the AUAB and the Hon'ble Minister of State for Communications on 03.12.2018. In view of the settlements that have been reached in respect of allotment of 4G spectrum, pension revision, implementation of government order with regards to the payment of pension contribution by BSNL and resolution of pending issues of 2nd PRC, and also with a view to provide some more time to the DoT and to the BSNL Management for sorting out the 3rd Pay Revision issue, the AUAB has decided to defer the indefinite strike until further intimation.
