**Sub: Issues affecting finalization of PPO for remaining employees retired under BSNL VRS-2019 - urgent requirement of settlement thereof.**

Sir,

The undersigned is directed to refer to the above cited subject and to forward herewith the lists of the retired employees under BSNL VRS-2019 as received from DOT wherein the issues due to which the PPOs could not been generated have been mentioned against each retired employee. The progress made is being closely monitored by the administrative ministry, DOT. A delay in settling these pending cases is adversely affecting the finalization of last tranche of ex gratia payable under BSNL VRS 2019.

2. As already conveyed vide this office letter of Even no. dated 20.07.2020, the fourth installment of Ex-gratia is expected to be received from DOT very soon. Due to pending cases for PPO generation, the total Ex-gratia amount is not being finalized.

3. This situation, if not immediately settled, may lead to erroneous amount of Ex-gratia calculations. A delay leading to incorrect assessment of funds from DoT may lead to a situation where retiree's claim will become the liability/responsibility of concerned authorities. To avoid such a situation, the Circle heads are requested to bestow their immediate personal attention to the pending cases for urgent settlement. Accordingly, the concerned circles are hereby requested to immediately coordinate with the respective CCAs for PPO generation by completing the pending activities mentioned against each case.

*[Further, vide letter dt. 15-07-2020, this office had also sought details of the cases in which the PO issued for absorption in BSNL is missing / non traceable / not finalized. So far report has been received only from Bihar and UP(East) circles. The remaining circles as per the list provided by DOT, may also immediately send the details of such case to this office. Any delay will similarly affect the process of finalization of funds adversely]*

As elaborated above, immediate action may please be taken under the supervision of Circle Heads to settle the pending issues in respect of all VRS optees so that Ex-gratia amount could be finalized without any shortfall and the consolidated amount is received from DOT in due time. **As has been expressly directed by DoT, "you are hereby advised for immediate completion of pending BSNLVRS 2019 cases and their submission to Pr.CCA/CCA concerned to enable issuance of PPOs."**

This may be treated as most immediate.
