Vide this office letter No. 4-02/2014–Restg Vol.V (Pt.) dated: 27.08.2020 & subsequent modifications dated 21.10.2020, instructions were issued for revision in consolidation of Business Areas, Category & Structure of BAs.

Consequent to the orders, proposals for modifications in BA structure were received from Jharkhand, WB, UP(W), UP(E), Chhattisgarh, Rajasthan, Odisha & Karnataka circles, along with the issue raised by finance FICCO on demerger activities and suggestions by different stake holders and Associations in BA structure.

Competent authority has considered the modification proposals of all the circles, suggestions by different stake holders & associations received till date and approved the following modifications in the BA structure:-

3. Completion of Demerger/merger activity:-

Being strategically required to improve the Administrative and operational efficiency, all the circles except MP circle are given a time line of 1 month to complete the demerger/merger activities as per the structure issued. If any circle fails to complete the activities within 1 month, the onus of any operational issues arising out of non completion of demerger activities will lie with CGM.

In view of the above modifications, the number of Business area in BSNL will be 159 instead of 158.

All other guidelines will remains the same as issued vide this office letter dated 27.08.2020 & subsequent modifications from time to time.
