For the subject mentioned above, please refer to your BSNL VR Scheme-2019.

2. The clause 7(ii) of the cited scheme says that:

"The VRS option of employee(s) facing Departmental/Judicial proceedings shall be accepted and Earned Leave encashment, Transfer grant, GPF/CPF and pension will be released provisionally as per Rule 69 of CCS Pension Rule 1972.

Provided that the payment of Ex-gratia and gratuity, shall be released only on the conclusion of and based on the outcome of vigilance/discplinary proceedings."

- It may kindly be clarified:
 - i. Whether retirement benefits of BSNL VR optees have been withheld on account of court cases filed by VR optees against deptt./BSNL seeking service benefits i.e. promotion, seniority etc.? If so, details thereof.
 - ii. Whether any Court case has been filed by BSNL VR optee, whose retirement benefits have been withheld on account of court cases filed against deptt./BSNL seeking service benefits i.e. promotion, seniority etc.? If so, details thereof.
