Subject: Notice served by Hyderabad (BA) management for recovery of huge amount after retirement on VRS against license fee of quarters

Ref.: NFTE letter dated 26.02.2020 addressed to Director HR, BSNL.

Please refer to letter dated 26.02.2020 from General Secretary, NFTE, New Delhi (copy enclosed).

In this regard, it is intimated that as per the Directorate of Estates OM No.18011/2/90-Pol.III dated 13.10.2003, the license fee chargeable for higher type accommodation is as under -

1. Three times the flat rate of licence fee shall be charged from those Government servants who are allotted Government accommodation of a type higher than entitlement, out of turn, on their own request.
2. In cases where due to adequate availability of quarters of a particular type, a Government employee is allotted accommodation of a type which is higher than his entitlement, only flat rate of license fee relevant to that type of accommodation is to be charged from such allottee.

You may therefore take necessary action on the above referred letter accordingly based on merits of individual case.

Subject:- Notice served by Hyderabad (BA) management for recovery of huge amount after retirement on VRS against licence fee of quarters – Case of Business area Hyderabad.

Sir,

It has been brought to our notice that notices have been served by the Hyderabad management to deposit the difference of licence fee which is a huge amount. The brief of the case is as follow –

- (1) The quarter was allotted to the staff on their requisition/application.
- (2) The applicant were entitle for type-II quarter but type-III quarters were allotted to them without option of the applicant.
- (3) The allottees of the quarters resided in the quarter since its allotment till their retirement(VRS).
- (4) The management never raised these issues and asked to the allottee either to vacate the quarter or pay the extra licence fee in the long period of their service.
- (5) That after retirement of employees in VRS the allottee officials have been directed to pay a huge amount as difference of license fee.

In the eyes of natural justice the act of management of Hyderabad BA is neither justified nor ethical as the type-III quarters were allotted to the officials by the management without their requisition to do so.

We, therefore request you to kindly arrange to issue suitable direction to the BA head of Hyderabad to not make the employees guilty that too after their retirement in VRS for the blunder done by the management at the time of allotment.
