Sub: Postponement of EPP Core module training & EPP Online Exams (only for Telecom stream) during Nov 2022 to FEB 2023 for conduct of JTO (T) & JE (T) Induction trainings.

In reference to above, it is informed that the LICE exam (under 50% internal quota) for promotion to Junior Telecom Officer (T) was held on 07-08-2022 and the same for Junior Engineer (T) is scheduled on 16-10-2022. On declaration of the results of these LICE exams, the Induction trainings are likely to start at the training centers w.e.f. October 2022. Hence, the resources of the training centers (e.g. classrooms, faculty, Hostel, Lab/PCs for Online Exam of Induction training) will be occupied in conduct of these Induction batches. Further, many trainers of training centres shall be engaged in Karmayogi Training starting from Oct-2022.

In view of above, the approval of the competent authority is conveyed to postpone the conduct of EPP up-gradation trainings (in Telecom Stream) from Nov 2022 to FEB 2023 to facilitate smooth conduct of JTO (T) & JE (T) Induction training of the qualified candidates of said LICE exams. The EPP upgradation trainings and EPP exams in all other non-telecom streams shall continue as usual.

The facility of nominations for the JUL-SEP 2022 cycle of EPP up-gradation training/Exam is kept opened and shall remain extended till Oct-22 and the individual/circle nodal officers for EPP can nominate in CTMS portal in this cycle of EPP up-gradation training/Exam for the remaining batches of the cycle. Training centres are advised to increase the batches of EPP in Sep-Oct-22 months in order to accommodate all candidates whose EPP training is due, especially in Telecom stream.


