With reference to above cited letters, we are very sorry to intimate you that the GM, Warangal not honouring the guidelines issued by Circle office vide letter No.-TT/STC/7-1/2016-18/87, dt-16-03-2018, Letter No.-TT/STC/7-1/16-18/20/16-18/90, dt-01-05-2018, and issued transfers irregularly against the policy vide letter No.-GMTD-WL/E-3/TV&P/TT/ATT/JE/2022-23/04, dt-27-04-2023.

We raised the issue in R-JCM held on 06-06-2023 and you kind enough instructed that "**Transfer Policy guidelines shall be followed scrupulously while issuing the orders**" (RJCM minutes, Page No.-18) Again, you kind enough assured us on 15-07-2023 on the same lines.

With good faith of management, we differed our proposed agitation vide No.-NFTE TS/Agitation/18/2023, dt-14-07-2023.

But, unfortunately the Warangal GM doing all actions against to the guide lines issued by Circle office, and harassing one individual official with ill motive. We are very sorry for it.

So, we request and demand you to cancel the irregular orders given by GM WL vide Letter No.-GMTD-WL/E-3/T&P/TT/ATT/JE/2022-23/04, dt-27-04-2023 and implement the transfer policy guidelines in Warangal without any deviation. Our GM Warangal is not at all honouring the instructions of circle office and acting indifferently.

In continuation of our notice vide ref. No.-NFTETS/Notice/17/2023, dt-01-07-2023, we are compel to organize the following agitational programme in the circle for settlement of demand.

- (1) Performing duties by wearing block badges on 10-08-2023.
- (2) Lunch hour demonstration at OA/BA head quarters on 11-08-2023.
- (3) Lunch hour demonstration at Circle office on 14-08-2023.
- (4) Day long Dharna at Circle office from 17-08-2023.
