Subject: Framework for Transfer of M2M SIM Ownership between M2M Service Providers (M2M SPs)/Licensees -reg.

In reference to the Telecom Regulatory Authority of India (TRAI) recommendations dated 22nd April 2025 on "Issues Related to Critical Services in the M2M Sector and the Transfer of Ownership of M2M SIMs", which have been by and large accepted by the Government, approval of competent authority is hereby conveyed in respect of the procedure for the transfer of ownership of M2M SIMs between M2M Service Providers/Licensees as below:

2. Procedure for Transfer of Ownership of M2M SIMs

- **2.1. Initiation by M2M Service User/Third Party:** The third party to whom M2M SP/Licensee is providing M2M Services shall initiate the transfer process by submitting a formal written request (format at Annexure A.1) to the existing M2M SP/Licensee (hereinafter 'transferor'), specifying details of the SIMs sought to be transferred and the intended transferee M2M SP/Licensee (hereinafter 'transferee').
- **2.2. No Objection Certificate by Transferor**: On receipt of the user's request, the transferor shall, within 15 days, issue a No Objection Certificate (format at Annexure A.2) to the concerned Access Service Provider(s), subject to no dues pending from the M2M Service user, confirming the user's request and specifying the SIMs for transfer.
- **2.3. Undertaking by Transferee**: The transferee shall submit a formal undertaking (format at Annexure A.3), addressed to the Access Service Provider(s), thereby accepting all responsibilities and liabilities pertaining to the transferred SIMs, inclusive of compliance with all KYC and related guidelines. The transferee shall also maintain, and provide on request, updated details of the physical custodians of such devices fitted with M2M SIMs obtained from the transferor entity.
- **2.4. Verification, KYC and update by Access Service Provider (ASP):** The Access Service Provider(s) shall verify both the NOC from the transferor and the undertaking from the transferee. Upon successful verification, the provider(s) shall carry out KYC again and update the subscriber records to reflect the change in ownership. At all times, each M2M SIM shall remain mapped to an M2M SP/Licensee, and there shall be no discontinuation of M2M service to the user.
