

- 3. Official's take home pay should be minimum of 1/3<sup>rd</sup> of the gross salary after all recoveries including the present applied loan. For the Higher Education Loan of Rupees One Lakh fifty thousand, recovery will be 25 months EMIs and Interest will be in 2 months total 27 months (The rate of Interest is 8% on 25 months).
- 4. The Officers / Officials having less than 3 years of service are not eligible.
- 5. Documentary proof regarding the study/course (latest Bonafide Certificate) has to be obtained from the Educational Institutions and the same has to be submitted to the Welfare section along with loan application form.
  - a) First priority will be given to those who have not having any kind of loans from Welfare Board.
  - b) Second priority will be given to those who are having pending loans from Welfare Board but having eligibility for getting loan i.e the take home pay should be 1/3 of the gross salary after all the recoveries including the present applied loan.
