**Sub:- Annual renewal of Group Term Insurance for BSNL employees (Executives and Non-executives) as per Master Policies No. 103006607/09/10, 103009084 and 103007627.**

### Present Status of Policy:

The Group Term Insurance for BSNL employees (Executives and Non-executives) as per Master Policies No. 103006607/09/10 (Rs. 50 lakhs for Executives), 103009084 (Rs. 20 lakhs for Non-executives) and 103007627 (Rs. 20 lakhs for executives above 50 years) are due for renewal w.e.f. 01.03.2026.

- The total premium paid for the current period i.e. from 01.03.2025 upto 28.02.2026 is Rs. 17, 87, 20,558/- i.e. (Rs. 17.87 Crores).
- Total number of deaths of BSNL employees from 01.03.2025 to 08.12.2025 is 201 out of which 44 employees have opted for LIC GTI Scheme.
- The total amount of claims against these 44 cases comes out to be Rs. 11.80 Crores.
