4. Circle Heads are requested to ensure that:
 - All Officers/Officials under their jurisdiction are correctly onboarded and mapped on the iGoT-Karmayogi portal;
 - iGoT profiles of the concerned Officers/Officials are duly updated;
 - the assigned mandatory courses and corresponding Comprehensive Assessments are completed by 31.03.2026; and

- completion of courses and assessments is ensured within the stipulated timeline so that the course consumption and assessment status is duly generated on the iGoT-Karmayogi portal for use during the APAR cycle.

Office Memorandum

Subject: Completion of Mandatory Courses on iGOT-Karmayogi Platform by All Officials of DoT.

Ref.: (i) OM 53-1/2024/iGOT-Trg dated 28.08.2025
(ii) DoPT OM No. T-28/27/2025-iGOT dated 04-07-2025

As per the directive conveyed through Office Memorandum No. T-28272025-iGOT dated 04.07.2025 by the Department of Personnel & Training (DoPT), all Central Government employees and officers are required to complete prescribed courses on the iGOT-Karmayogi portal annually. This completion will be reflected in the Annual Performance Appraisal Reports (APARs) beginning the 2025-26 reporting period.

2. Accordingly, the following instructions are hereby issued to all officials and officers under DoT:

- The list of Mandatory Courses to be completed has been finalized and 6 courses are assigned for each of the following levels of officers/officials:
 - i. Joint Secretary (JS) and above & equivalent
 - ii. Director/DS & equivalent
 - iii. Under Secretary/ADG/ADET & equivalent
 - iv. SO/ASO/AD/JTO/PS & equivalent
 - v. MTS
- These courses will get reflected as targets in the “My iGOT” section of iGOT profile of respective user.
- Officers must log in to the iGOT Karmayogi portal and ensure that their profile is updated to correctly reflect their current position/designation under the correct organization (“Department of Telecommunications”) in the iGOT portal for corresponding course assignment. (Guide for iGOT Profile Update enclosed)
- For the reporting year, all officials must ensure completion of at least 50% of courses assigned as per DoPT guidelines.
- In addition to completion of courses, a Comprehensive Assessment Framework will be rolled out. All employees must successfully pass assessments for 3 selected courses; separate instructions/directions regarding these assessments will be issued in due course.
- Every Officer/official must complete the courses prescribed for their position/level and also complete the prescribed Comprehensive

Assessment by 31st March 2026. Level wise detailed course list is enclosed as Annexure-I.

- The status of course completion and assessment will be directly fetched from iGOT and reflected in APARs from the assessment year 2025-26.

3. Non-compliance may impact the Annual Performance Appraisal Report (APAR) as mandated by the revised guidelines. Heads of Units/Field Offices are requested to monitor and confirm compliance within their administrative domain.

संदर्भित इस कार्यालय पत्र और विभाग द्वारा जारी विशानिर्देशों के क्रम में, यह अनुरोध किया जाता है कि प्रत्येक नियुक्त कर्मचारी को वित्तीय वर्ष 2025-2026 की चौथी तिमाही में iGoT कर्मयोगी प्लेटफॉर्म पर कम से कम आठ (08) घंटे का प्रशिक्षण पूरा करना होगा।

In continuation of this office letter under reference and the guidelines issued by DoPT, it is requested every on-boarded employee must complete at least Eight (08) hours of training on iGoT Karmayogi platform in Q-4 of F.Y. 2025-2026.

2. निगम/परिमंडल कार्यालय/ व्यवसायिक क्षेत्र/ परिचालन क्षेत्र में पदस्थ अधिकारियों/कर्मचारियों को यह निर्देश जारी किए जाने का अनुरोध है कि iGoT पोर्टल पर जेई एवं उससे ऊपर के स्तर के कर्मचारियों द्वारा न्यूनतम आठ (08) घंटे का प्रशिक्षण तथा सभी समूह 'सी' एवं 'डी' कर्मचारियों द्वारा कम से कम एक (01) प्रशिक्षण निर्धारित समयावधि अर्थात् वित्तीय वर्ष 2025-26 की चतुर्थ तिमाही (Q-4) के भीतर अनिवार्य रूप से पूर्ण किया जाए। उक्त प्रावधान को सभी दूरसंचार परिमंडलों के मुख्य महाप्रबंधकों के आईपीएमएस में पहले ही सम्मिलित किया जा चुका है। इसके अतिरिक्त, चतुर्थ तिमाही (जनवरी-2026 से मार्च-2026) के लिए कर्मचारियों के आईपीएमएस स्कोर कार्ड में नियंत्रक अधिकारी द्वारा उपयुक्त वैंटेज प्रदान किए जाने पर भी विचार किया जाए।

[नोट: केवल वही प्रशिक्षण घंटे/संख्या मान्य होंगे जिनके लिए प्रशिक्षण पूर्ण करने के उपरान्त प्रमाणपत्र जारी हुआ है। प्रगति-अवस्था वाले प्रशिक्षण घंटे/संख्या को मान्य नहीं किया जाएगा।]

2. It is requested to issue suitable directions to the officers/officials posted in Corporate/Circle office/ BA/ OA to complete minimum eight (08) hours of training by JE & above level employees and atleast ONE training by all the Group C & D employees on iGoT portal within stipulated time i.e. Q-4 of F.Y. 2025-2026. The

same has already been incorporated in the IPMS of the CGMs of all the Telecom Circles. Further, suitable weightage may be offered to all employees in their IPMS Score Card of Fourth Quarter (JAN.-2026 to MAR.-2026) by the controlling officers.

[Note: - The training hours/count will be calculated for the training course for which the certificate will be issued after completion of training. The incomplete (In-progress) training hours/count will not be taken into account.]

Subject: Completion of Mandatory Courses and Assessments on iGOT Karmayogi portal of DoT officers deputed in BSNL-reg.

As per the directive conveyed through OM No. T-28/27/2025-iGOT dated 04-07-2025 (enclosed) by the Department of Personnel & Training (DoPT), all Central Government employees and officers are required to complete prescribed courses on the iGOT-Karmayogi portal annually along with a comprehensive assessment. This completion will be reflected in the Annual Performance Appraisal Reports (APARs) beginning the 2025-26 reporting period.

2. Accordingly, officers in DoT have been assigned six (06) mandatory courses at different levels (MTS, ASO/SO, JTS/STS, DS/Director and JS & Above) vide OM No. 53-1/2024/iGOT-Trg. Dated 07-10-2025(enclosed). Since many officers of DoT are working in BSNL whose iGOT profiles are under BSNL-MDO, it is requested that the six (06) mandatory courses along with the respective comprehensive assessments may be assigned level wise to all such DoT officers in BSNL if not already assigned as DoPT guidelines. 3.
