Sub : Closure of BSNL Offices located in Delhi/New Delhi on 11.09.2026 on the occasion of 18th BRICS Leaders' Summit in Delhi - reg.

Kindly refer to the Office Memorandum No. 12/7/2023-JCA dated 03.09.2026 issued by the Department of Personnel & Training (DoP&T) regarding closure of Central Government Offices located in Delhi/New Delhi on **11.09.2026 (Friday)** in view of the **18th BRICS Leaders' Summit** being held in New Delhi from 11th to 13th September, 2026. Also, the Department of Public Enterprises (DPE) vide its letter No. PP-II-7/6/2022-DPE (FTS-13936) dated 09.09.2026, while forwarding the aforesaid O.M. issued by DoP&T, has advised that the CPSEs may also consider keeping their **Offices located in Delhi/New Delhi** closed on 11.09.2026 (Friday) in view of the 18th BRICS Leaders' Summit.

2. Further, the Delhi Traffic Police has issued an advisory regarding traffic restrictions, diversions and closure of various roads/areas in New Delhi in connection with the BRICS Summit. The **Janpath area**, among other areas, has also been specifically mentioned in the advisory for closure/restriction in view of the Summit.

In view of the magnitude of this event and considering the prevailing security and traffic restrictions in Delhi/New Delhi, and to minimize inconvenience to the employees of BSNL, it has been decided that BSNL Corporate Office, Janpath, New Delhi and BSNL Offices/Subordinate Offices located in Delhi/New Delhi shall remain closed on Friday, 11.09.2026.

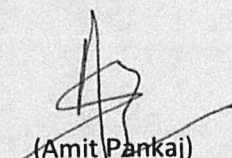
OFFICE MEMORANDUM

The undersigned is directed to say that the BRICS Business Forum and 18th BRICS Leaders' Summit are scheduled to be held from 11-13 September, 2026 at Bharat Mandapam, New Delhi. The Summit will be attended by leaders from about thirty BRICS members and partner countries, Heads of International Organizations and business representatives from BRICS nations including India.
