ORDER

Sub: Transfer and Postings in the cadre of Group C [Clerical Staff] for S & M activities to Hyd BA –Reg.

Ref: This office letter of even no.s dated 01-09-2026 & 03-09-2026.

The Group C [Clerical Staff] working in Circle Office, Hyderabad [as per Annexure-I] are hereby Transfer/deputed as per the details given below with immediate effect for enhancing the growth of Sales & Marketing in FTTH / Mobile Connections / CSC in Hyderabad BA and for gainful deployment of surplus staff on deputation basis for a period of two years from the date of their joining in Hyderabad BA. This deputation /transfer order is issued as a special case on administrative grounds for increasing growth of Sales and Marketing of FTTH and mobile SIMs activities to meet the market related changes in business of the company.

The period of deputation shall be for two years only. However, willing employees may continue to serve in HYD-BA on deputation beyond the prescribed period, subject to the approval of the CGMT.

On completion of the deputation period, the employees may be relieved by HYD-BA and repatriated to the O/o CGMT, Hyderabad after completion of all requisite formalities. This deputation may be curtailed at any time, depending upon the exigencies of clerical staff's services in the O/o CGMT. Lien in respect of the above officials will be maintained under the O/o CGMT. In case of retirement on superannuation / voluntary retirement / resignation of the employees arises before completion of two years of deputation, the employees will be repatriated to CGM office before 3 months of date of retirement on superannuation/ voluntary retirement /resignation as the case may be.

*PGM HTD is requested to accommodate these officials as per their priority of options mentioned in the Annexure-I.

All the officials may be relieved within 3 days.

Necessary charge reports may be forwarded to all concerned.

Relieving & joining entries should be made in SAP/ERP/SB.

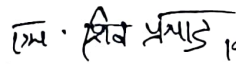
