OFFICE MEMORANDUM

Subject: Amendment to BSNL "TA/DA rules 2002"

The "BSNL TA/DA Rules 2002" were issued vide letter dated 22.10.2002 and subsequently amended vide O.M. No. 7-6/2006-EF/Vol.II (Pt) dated 08.09.2010 pursuant to 2nd PRC. The rates of Hotel Accommodation and Daily Allowance (DA) for domestic tours were last revised vide letter No. 1-15/2016-PAT(BSNL) dated 15.02.2017.

2. The existing rates of Daily Allowance and Hotel Accommodation for domestic tours have been reviewed in view of the prevailing market rates and the financial position of the Company. The BSNL Board vide Resolution No. BSNL/SECTT/BOARD C.R. No. 17 of 2026-27 dated 21.09.2026 has approved revision of the said rates. Accordingly, Para (C) and Para (D) of O.M. no. 7-6/2006-EF/Vol. II (Pt) dated 08.09.2010, as subsequently revised vide letter no 1-15/2016 PAT(BSNL) dated 15.02.2017, prescribing the rates of Daily Allowance and Hotel Accommodation, respectively, are hereby revised as per the enclosed **Annexure**.

3. This amendment order shall take effect from 01.10.2026.

4. All other provisions of the "BSNL TA/DA Rules 2002", as amended from time to time shall remain unchanged.
